
INSTRUCTIONS: -

(a) Identify the corner by reference to the U.S. public land survey system.

O = Corner monument restored.

Quarter corner to Sections 7 and 18, T.34N., R.14E., Forest County, Wisconsin.




(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1859, James McBride set a wood post with the following B.T.'s: Sugar, 12", N.21°W., 15 links (9.90 feet); Hemlock, 36", S.63°E., 13 links (8.58 feet).

In 1937, A.J. Vronch found a 4" hemlock that had been recently placed with no b.t.s to post. He placed a metal location poster on the Northeast side of a 4" elm from which the corner bears N.41°E., 0.36 chains (23.76 feet).

In 1988, A. Harrison, R.L.S., found the metal location poster on the ground next to a 12" elm. At N.41°E., 23.76 feet from elm found a post hole with no remains of post evident. Accepted post hole as best available evidence of corner location and monumented same.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (witness monuments shall be made of concrete, natural stone, iron orother equally durable material.)
- (d) Show a plan view drawing depicting the relevent monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
  - 1. 2½" x 36" aluminum monument with tablet stamped to identify the corner lcoation.
  - 2. Sugar, 4", N.60°E., 51.33 feet.
  - 3. Sugar, 5", S.21°E., 20.61 feet.
  - 4. Sugar, 5", S.73°W., 30.65 feet.
  - 5. Steel sign post, Northwest, 0.79 feet.
