

In 1859, James McBride set a wood post with the following B.T.s: Hemlock, 16", S.52W., 16 links, (10.56'); Birch, 8", N.46E., 224 links, (15.84').


In 1936, H. Powell found a wood post scribed for the corner with the following B.T.s: Birch snag, 8",  $N.41\frac{1}{2}E.$ , 12.21 feet; Hemlock, 12", S.28E., 13.86 feet. He placed a metal location poster on a Yellow Birch, 12", N.86W., 8.58 feet, poster is on the east side of the tree.

In 1987, Alan Harrison, R.L.S.) found: Location poster on a 14" Birch Snag, pulled S.86E., 8.58 feet and found a post point and remains of a rotted post. From post point at; N.41E. 12.2 feet a 10" birch stump; S.28W. 13.9 feet a 14" hemlock stump; S.52W. 10.6 feet to remains of a hemlock stump. Accepted post point as best remaining exidence of original gorner. Perlaced post point with a 21" X 36" aluminum monument; the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)
