


In 1859, James McBride set wood post with the following BT: Lind, 16", S.45°E., 16 links.

In 1914 and 1922, N. Smith found original BT still standing.

May 2, 1985, Al Harrison found no evidence of corner position. Corner was restored by retracement of Smith's 1914 survey, using Smith's southwest and west one-sixteenth corners.
