
INSTRUCTIONS:

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1858, James McBride set wood post with the following BTs: Elm, 10", N.28°E., 36 links; Elm, 6", S.28°W., 15 links.

In 1974, Tom Tallier found corner of old fence line running north and west. Found no bearing trees.

June 12, 1984, Alan Harrison searched area around fence corner and an area N.13°E., 235.01', where proportionate position is. Fence corner has fences running west, N.12°E. Found no evidence of corner.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

 Describe witness monuments.

Show the distances between the corner as previously restored or reestablished and (1) the corner as restored or reestablished, and (2) to at least 2 of the witness monuments shown on the drawing in (d), above.


(f) Was the corner restored through acceptance of (1) an obliterated evidence location, or, (2) a found perpetuated location?
