
INSTRUCTIONS

This record shall show the location of the corner and shall include all of the following nine elements (a through i).

(a) Identify the corner by reference to the U.S. public land survey system.

O - Corner monument restored.

Section Corner to Sections 8, 9, 16, and 17, T.34N., R.16E.



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1858, James McBride set wood post with the following BTs: Hemlock, 12", N.20°W., 24 links; Cedar, 8", N.22°E., 20 links; Hemlock, 12", S.39°E., 18 links; Cedar, 8", S.52°W., 15 links.

December, 1935, road survey found fence corner, iron peg, and Forest Service poster. Fence runs south and west.

March 29, 1968, Resvick found fence post with Forest Service poster on it. From post, Cedar stump, S.52°W., 9.90'. October 25, 1968, Resvick--Hemlock stump mound bears S.39°E., 13.5'

April 19, 1984, Alan Harrison found corner, as described above, plus N.20°W., 15.8', remains of Hemlock stump. Accepted as the original corner.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)


