
## U. S. PUBLIC LAND SURVEY MONUMENT RECORD

This record shall show the location of the corner and shall include all of the following nine elements (a through i).

- Identify the corner by (8) reference to the U.S. public land survey system.
  - O = Corner monument restored.

Quarter corner to Sections 24 and 25, T.34N., R.16E.




Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1858, James McBride set post with the following BTs: Sugar, 16", S.74°E., 15 links; Beech, 10", N.32°E., 12 links.

October 15, 1984, Alan Harrison set proportionate position. Searched area, found no evidence of corner location.

- In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.) Describe witness monuments.

- 1. Corner position marked by "X" on a flat rock 4" above ground 3' x 2' x 12" below ground.
- 2. Witnessed by a 2" x 30" aluminum monument stamped to identify the corner, S.89°E., 12.33'
- 3. Sugar, 8", N.09°E., 23.88'
- Red Oak, 12", S.47°E., 58.82'
- Sugar, 6", S.85°W., 48.27'
- 6. Steel Sign Post, East, 13.97'
