

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1859, James McBride set wood post with the following BTs: Sugar, 15", N.22°W., 22 links; Sugar, 10", N.55°E., 44 links; Sugar, 10", S.26°W., 46 links; Sugar, 12", S.33°W., 38 links.

In 1907, J. J. Melindy set new Elm post and the following BTs: Maple, 10", S.40°E., 4.5 feet; Birch, 10", N.76°W., 9.02 feet.

June 4, 1985, Alan Harrison found brass cap monument and remains of Elm post. Also found a stump depression, S.40°E., 4.5 feet and a stump depression at N.76°W., 9.0 feet. Monument was set by Kolbe in 1961.
