



## U. S. PUBLIC LAND SURVEY MONUMENT RECORD


INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through 1).

(a) Identify the corner by reference to the U.S. public land survey system. Corner monument restored.

Quarter Corner common to Sections 20 and 29,

T.35N., R.15E., Forest County, Wisconsin.



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1859, James McBride corrected west and at 40.00 chains set one quarter post and made the following B.T.'s: Sugar, 10", N.27°E., 31 links (20.46 feet); Sugar, 10", S.18°E., 22 links (14.52 feet).

In 1909, Nathan Smith found quarter corner at 39.31 chains (2594.46 feet) from West. Set new post and said original witness' okay.

In November 1990, Al Harrison (RLS) chained from west and at 2595 feet found squared old wood post on ground. Stump holes of original B.T.'s at original bearings and distances. Old blazed line running east and west. Set aluminum monument and made new references.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, If the location is within a municipality, to at least 2 witness monuments. (witness monuments shall be made of concrete, natural stone, Iron orother equally durable material.)
- (d) Show a plan view drawing depicting the relevent monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
  - 1. 2½" x 36" aluminum monument stamped to identify corner location.
  - Sugar, 11", N.32°E., 3.81 feet.
  - Sugar, 7", S.36°W., 10.90 feet.
  - Sugar, 11", N.54°W., 15.27 feet.
  - Steel Sign Post, Southeast, 1.22 feet.
