

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1858, James McBride set a wood post with the following BTs: Hemlock, 15", N.80°E.,

24 links; Birch, 7", S.42°W., 10 links.

In April, 1983, Milo Stefan found a 4" x 4" wood post lying on the ground. The post was not scribed. No trace of BT remains were located from post and record bearings and distances. Wood post was not considered the correct position for the corner and had no supporting evidence. Set a 2" x 36" aluminum monument with cap stamped to identify the corner location at lost proportional position.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)
