


(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1858, James McBride set a wood post with the following BTs: Hemlock, 6", N.67°E., 4 links; Birch, 12", N.57°W., 8 links.

In April, 1983, Milo Stefan found no trace of this corner and restored it by lost methods. He placed a 2" x 36" aluminum monument in a mound of stone, with cap stamped to identify the corner.
