




(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

Original Survey in 1858 by James McBride. Set wood post from which the following bear: Black Ash, 7", S.35°W., 14 lks., Cedar, 8", N.69°E., 6 lks. South, 22.00 chains stream 15 lks. wide runs Northeast.

In 1995, Alan Harrison, RLS with the Forest Service, established Global Positioning Satellite control on the Northeast Section Corner of Section 30 and the Southeast Section Corner of Section 30: Using this control and original calls, could not recover any corner evidence. Reestablished the corner position at mid-point and on line between the Northeast and Southeast Section Corners of Section 30. At the corner position, set a  $2\frac{1}{2}$ "x36" aluminum pipe monument with an aluminum cap stamped to identify the corner. Blazed and scribed new bearing trees as listed below.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (witness monuments shall be made of concrete, natural stone, from orother equally durable material.)
- (d) Show a plan view drawing depicting the relevent monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
  - 1. 2½"x36" aluminum monument with cap stamped to identify corner
  - 2.Aspen, 12", N.67°E., 3.64 feet
  - 3.Black Ash, 5", S.16°E, 18.12 feet
  - 4.Black Ash, 5", S.12°W, 8.73 feet
  - 5.Steel Sign Post, 0.90 feet Southeast of monument


