



1993- Corner search made by John Garske, found 1 1/2" IP in mound of stones as noted to us by Ken Mullens with Northern Hardwoods, formerly Connors Lumber co. The iron pipe was set some 40 years ago and hs been used and accepted since then. I accepted corner location and placed a 2 1/2" Bernsten A-1 Federal aluminum monument. I made the following new accessories.

 - 6. Hemlock 16" N35°W 8.55 feet


