



Original survey in 1859 by James McBride. Set wood post and the following bearing trees; Sugar, 10", N.22°W., 10 links, Sugar, 15", N.83°E., 24 links, Sugar, 12", S.75°E., 30 links, Sugar, 15", S.17°W., 52 links.

In 1980, William Cochrane, R.L.S., found a 2" diameter iron pipe in a mound of stone and an old post lying next to pipe. Found stump holes N.22°W., 10 links, N.83°E., 24 links, S.17°W., 52 links. In place of iron pipe set a 2" x 36" galvanized iron pipe with a brass cap stamped to identify corner. Blazed and scribed new bearing trees; White Ash, 11", S.85°E., 4.15 feet, White Ash, 9", S.37°E., 21.38 feet, Maple, 6", S.31°W., 23.57 feet, White Ash, 11", N.62°W., 6.89 feet.

On November 5, 1991, Alan Harrison, R.L.S., found the monument and bearing trees as described above. The White Ash bearing trees incorrectly called Basswoods on Cochranes Corner Certificate and in field book. Also found Northwest White Ash bearing tree cut down by those unknown. Blazed and scribed 1 new bearing tree; Sugar, 6", N.55°W., 35.15 feet. Set a steel sign post 0.50 feet Northeast of monument.
