



U. S. PUBLIC L'AND SURVEY MONUMENT RECORD


INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through 1).

(a) [dentify the corner by reference to the U.S. public land survey system.

O = Corner monument restored.

Quarter corner common to sections 5 and 8, T.36N., R.16E. Forest County, Wisconsin



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1858, James Mc Bride set a wood post with the following B.T.'s: Cedar, 10", N.43°E., 29 links; Sugar, 12", S.41°E., 22 links. 2.50 chains West entered Cedar swamp, North and South 5.00 chains West stream, 4 links, South 16.50 West, leave swamp, NW and SE.

In 1928, Goodman Co. set 3" Cedar post and 2"x32" flue pipe. Orginal B.T.'s: Cedar, 14", N.38°E. 29 links, (19.14 feet); Maple, 17", S.43°E., 22 links, (14.52 feet).

On October 15, 1991, Alan D. Harrison (RLS) paced from North-South call on stream East 330 feet and found a 2" flue pipe and cedar post remains. From flue pipe the following bear: Cedar, 15", N.40°E, 19.1 feet, fallen on ground; maple stump, 20", S.40°E., 14.5 feet. Blazed Hemlocks facing corner. Replaced flue pipe with monument in mound of stone as best evidence of corner location.

- (c) In the plan view drawing below, provide reference thes to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (witness monuments shall be made of concrete, natural stone, iron orother equally durable material.)
- (d) Show a plan view drawing depicting the relevent monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
- 1. 2½"x36" Aluminum monument with tablet stamped to identify the corner.
- 2. Hemlock, 9", N.58°E., 28.13 feet.
- 3. Hemlock, 9", S.10°E., 18.85 feet.
- 4. Sugar, 7", N.55°W., 15.68 feet.
- 5. Steel Sign Post, 6th, 1.23 feet, S.W. of Medical Control
