U. S. PUBLIC LAND SURVEY MONUMENT RECORD


INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through 1).

(a) Identify the corner by reference to the U.S. public land survey system.

O - Corner monument restored.

Quarter corner common to sections 5 and 4 T.36N., R.16E. Forest County, Wisconsin




(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1858, James Mc Bride set a wood post with the following B.T.'s: Hemlock, 18", S.16°W., 17 links (1.22 feet), Elm, 8", S.54°E., 30 links (19.80 feet).

In 1927, Goodman Lumber Co. set $3\frac{1}{2}$ " Hemlock post and in 1928 set a 2"x32" flue pipe. Found remains of old post set by either Jenkins of Brown Lumber Co. Several trees notched to mark post. No B.T.'s.

On October 16, 1991, Alan D. Harrison (RLS) found 2" flue pipe just West of small grove of Hemlocks. Orginal Hemlock B.T. is now just a stump depression. No evidence of orginal S.E. B.T. remaining. Also, found location poster dated 1940 and 1953 on 20" Elm snag, S.3°W., 16.5 feet. Replaced flue pipe with monument as best evidence of corner location.

- (c) in the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (witness monuments shall be made of concrete, natural stone, Iron orother equally durable material.)
- (d) Show a plan view drawing depicting the relevent monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
- 1. 2½"x36" Aluminum monument with tablet stamped to identify corner.
- 2. Sugar, 18", S.47°E., 9.82 feet.
- 3. Sugar, 6", S.69"W., 13.48 feet.
- 4. Sugar, 6", N.56°W., 25.40 feet.
- 5. Steel Sign Post, 6', East, 1.37 feet.
