

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1858, James McBride set a wood post with the following BTs: Fir, 8", N.34°W., 12 links; Aspen, 12", N.58°W., 22 links; White Pine, 8", S.79°E., 30 links; Fir, 7", S.61°W., 20 links.

In 1926, Goodman Lumber Company found 5" Cedar post; rotted stump of Fir, N.34°W., 12 links; White Pine, 14", S.79°E., 30 links--blazes on Pine very plain. Set flue pipe 16" above ground level.

In 1987, Alan Harrison (RLS) found the following: 2" iron pipe (flue pipe) as set by Goodman; original Pine BT stump at S.79°E., 19.80 feet from pipe. Accepted this pipe as the true perpetuated location of corner. Replaced pipe with a 2" x 36" aluminum monument with tablet stamped to identify corner.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

 Describe witness monuments.
- (d) Show a plan view drawing depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.

- 3. Spruce, 9", S.74°E., 59.78 feet
- 4. Red Maple, 6", S.21°W., 23.13 feet
- 5. Spruce, 7", N.89°W., 36.13 feet
- 6. Steel Sign Post, Southeast, 1.06 feet
