
## U. S. PUBLIC LAND SURVEY MONUMENT RECORD.

INSTRUCTIONS

This record shall show the location of the corner and shall include all of the following nine elements (a through i).

- (a) Identify the corner by reference to the U.S. public land survey system.
  - Corner monument restored.

Quarter Corner to Sections 17-20, T.36N., R.16E., Forest County, Wisconsin.



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1858, James McBride set a wood post with the following B.T.'s: Aspen, 10", N.40°W., 28 links (18.48 feet); Birch, 8", S.13°E., 10 links (6.60 feet).

In 1911, J. Melandy found original Birch, 14", and decayed original Aspen stump from which he set a 4" x 4" Elm post and the following new B.T.'s: Birch, 8", N.66 3/4°W., 30 1/4 links (19.965 feet); Basswood, 14", S.47 3/4°W., 34 2/4 links (22.77 feet); Birch, 9", S.73 1/4°E., 17 links (11.22 feet).

In 1989, Alan Harrison, RLS, found no evidence of original or Melandy's corner or accessories. Set corner by proportionate measure.

- (c) In the plan view drawing below, provide reference tles to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

  Describe witness monuments.
- (d) Show a plan view drawing depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north,
  - 1. 2½" x 36" aluminum monument with tablet stamped to identify the corner.
  - 2. Sugar, 11", N.04°E., 19.34 feet.
  - 3. Sugar, 9", S.76°W., 32.21 feet.
  - 4. Sugar, 12", N.61°W., 47.68 feet.
  - 5. Steel Sign Post, North, 0.43 feet.
