
U. S. PUBLIC LAND SURVEY MONUMENT RECORD.

INSTRUCTIONS

This record shall show the location of the corner and shall include all of the following nine alements (a through 1).

- (a) Identify the corner by reference to the U.S. public land survey system.
 - Corner monument restored.

Quarter Corner to Sections 16-17, T.36N., R.16E., Forest County, Wisconsin



(b) Describe any record evidence, monument evidence, occupational evidence, teatlmonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1858, James McBride set a wood post with the following B.T.'s: Aspen, 12", S.84°W., 5 links (3.30 feet); Aspen, 12", N.86°E., 6 links (3.96 feet).

In 1928, Goodman Lumber Company found a 5" maple post set by Blackwell Company with no original B.T. evidence from post. Goodman set a flue pipe for the corner.


In 1988, Alan Harrison, RLS, found 2" iron pipe in a rock mound with the following B.T.'s: Birch, 18", North, 19.40 feet; Double Sugar, 14", S.32°W., 7.90 feet. Next to iron pipe found post point on ground. Accepted iron pipe as the corner.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

 Describe witness monuments.
- (d) Show a plan view drawing depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
 - 1. $2\frac{1}{2}$ " x 36" aluminum monument with tablet stamped to identify the corner.
 - 2. Yellow Birch, 18", North, 19.40 feet. (Dead)
 - 3. Sugar, 7", S.20°E., 31.24 feet.
 - 4. Sugar, 7", S.42°W., 56.58 feet.
 - 5. Steel Sign Post, South, 1.35 feet.
 - 6. Dbl. Sugar 14" & 20" S.32°W. 7.78'feet.
