(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1858, James McBride set a wood post for the corner and the following corner references: Cedar 10" S22°E 8 1ks. Cedar 8" S48°W 18 1ks.

In 1926, Goodman Lumber Company set a wood post by proportional measurement and then replaced it with flue pipe. Found an 8" leaning cedar tree 5 paces Southeast with a blaze on it.

In 1988, John Schulke found two Cedar stumps that fit the GLO notes. Placed 2 $1/2^{\prime\prime}$ dia. X 60' aluminum monument.

 - 5. Balsam 8" Sl1°W 76.35 feet
 - 6. Steel sign post Southeast 1.0 feet
