No original evidence was recovered.

Description of monument and accessories I established to perpetuate the original location of this corner.

At the corner position as described above, I set a 1" inside diameter galvanized iron pipe, 30 inches long, from which the following bear:



In 1977, William B. Cochrane, a Land Surveyor with the U.S. Forest Service, restored the corner position by using an old fence line which runs North and South and the centerline of an old railroad grade which runs East and West. He set a 1" diameter galvanized iron pipe 30" long with a reference monument located on the South edge of the railroad grade being a $2\frac{1}{2}$ " diameter by 30" long aluminum pipe monument stamped as follows: T37N, R12E, R13E, S25, S30, S31, S36, 1977, S-1107, REFERENCE MONUMENT, N 1°W, 7.0 feet, from which the following bear:
