

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1865, J. L. Nowlin set a wood post with the following B.T.'s: Fir, 6", N.40°E., 7 links (4.62 feet); Spruce, 8", N.58°W., 6 links (3.96 feet).

In 1935, W. A. Goulet (CCC) found a Black Spruce post in good condition. Metal tag on west side of quarter corner post.

In 1972, Resvick (RLS) found a plantation post dated 1936 and top of older squared post by the plantation post.

In 1990, Alan D. Harrison (RLS) found both the plantation post and the other post lying down, dug around and found post hole, also a metal location tag Northwest of post hole. Accepted the above as best evidence of the corner location.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (witness monuments within a manuments, and a stone, iron orother equally durable material.)
