
U. S. PUBLIC LAND SURVEY MONUMENT RECORD

INSTRUCTIONS:

This record shall show the location of the corner and shall Include all of the following nine elements (a through I).

(a) Identify the corner by reference to the U.S. public land survey system. = Corner monument restored


(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

Original Government Survey in 1858 by Alfred Millard. North between sections 7 and 12, at 40.00 chains set wood post from which the following bear; Hemlock, 8", N.28°E., 30 links, Fir, 10", S.35°W., 25 links.

On 7-19-99, Alan D. Harrison, RLS with the U.S. Forest Service searched the corner area and found the following; a 2 inch diameter galvanized iron pipe, 4 feet long with location posters from Consolidated Papers and U.S. Forest Service attached. Accept the iron pipe as the best available evidence for restoring the corner position. In place of pipe set a 2 1/2 inch diameter aluminum pipe monument, 3 feet long, 2 1/2 feet in the ground with an aluminum cap stamped; T.38N., R.13E., R.14E., S.7, S.12, 1/4, 1999, R.L.S. 1651. Blazed and scribed new bearing trees as noted below.

- 1.) 2 1/2" x 36" aluminum monument stamped to identify corner.
- 2.) Sugar, 9", N.24°E., 30.24 feet (new)
- 3.) Balsam, 7", S.10°E., 35.45 feet (new).
- 4.) Sugar, 12", N.49°W., 36.86 feet (new)
- 5.) Steel Sign Post, Southwest, 0.60 feet
