
U. S. PUBLIC LAND SURVEY MONUMENT RECORD

INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through 1).

- (a) identify the corner by reference to the U.S. public land survey system.
 - O Corner monument restored.

Quarter Corner common to Sections 32 and 5 T38N, T37N, R13E, Forest County, Wisconsin



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

Original Government Survey in 1858 by Alfred Millard.
West, 40.00 chains, set wood post, Fir, 10", N 45°E, 25 1ks., Fir, 10", S60°W, 4 1ks.

In 1966, Jean Resvick, a Land Surveyor with the U.S. Forest Service, restored the corner position by proportionate measurement between the township corner and the NE corner of Section 4. He set a 2" diameter galvanized iron pipe with a brass cap stamped as follows: T38N, R13E, 1/4, S32, S5, T37N, 1966, S-802 from which the following bear:
