Corner recovered by Ray Leigh, Consolidated Forester, in 1948. Set 4" cedar post. This corner maintained by Consolidated Foresters since 1950.

Description of corner evidence found: Recovered 4" cedar post squared and scribed S17 1/4-S S20 in poor condition. Also recovered a 1-1/2" iron pipe setting beside it.

No trace of original BT's was visible.

Description of monument and accessories I established to perpetuate the original location of this corner.

Replaced 4" cedar post with 2-1/2" Berntsen, A-1 Federal Monument, aluminum with magnet installed in cap and base. Pipe projects one foot above ground. Old post set up beside new pipe. Cap stamped -





In 1976, Phil Hansen, RLS with Consolidated Papers Inc. recovered wood post as set by Ray Leigh in 1948. Replaced post with a 2 1/2 inch diameter Bernsten A - 1 Federal Monument stamped; S-498, T38N, R14E, 1/4, S17, S20, 1975. Blazed and scribed bearing trees as noted below.
