

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

Original Government Survey in 1865 by H. & J.L. Nowlin. North between sections 17 and 18, at 40.00 chains set wood post from which the following bear; Cedar, 12", N.61°W., 6 links, Sugar, 15", N.65°E., 13 links.

On 4-22-98, Alan D. Harrison, RLS with the U.S. Forest Service, searched the corner area using Global Positioning Satellite control and natural feature calls. No corner evidence was recovered. The corner position is reestablished through lost corner proportionate methods. At the corner position set a 2 1/2 inch diameter aluminum pipe monument, 3 feet long, 2 1/2 feet in the ground, with an aluminum cap stamped; T.38N., R.14E., 1/4, S.17, S.18, 2000, R.L.S. 1651. Blazed and scribed new bearing trees as noted below.
