





LEGAL DESCRIPTION

Being the Southwest one-quarter of the Southwest one-quarter (SW 1/4 x SW 1/4) and the Southeast one-quarter of the Southwest one-quarter (SE 1/4 x SW 1/4), Section 21, Township 34 North, Range 15 East, Town of WABENO, Forest County, Wisconsin being more particularly described as follows:

BEGINNING at the Southwest corner of said Section 21, T34N, R15E; thence S89°43'00"E along the South line of said Section 21, a distance of 1312.67 feet to the West one-sixteenth (W1/16) corner on the South line of said Section 21; thence continuing along the South line of said Section 21, S89°43'00"E, a distance of 1312.68 feet to the South one-quarter (S1/4) corner of said Section 21; thence N02°36'35"E along the North-South one-quarter (N-S 1/4) line of said Section 21, a distance of 1321.75 feet to the Center-South one-sixteenth (C-S 1/16) corner of said Section 21; thence N89°34'39"W along the South one-sixteenth (S1/16) line of said Section 21, a distance of 1318.30 feet to the Southwest one-sixteenth (SW1/16) corner of said Section 21; thence continuing along the South one-sixteenth (S1/16) line of said Section 21, N89°34'39"W, a distance of 1318.56 feet to the South one-sixteenth (S1/16) corner on the West line of said Section 21; thence S02°06'09"W along the West line of said Section 21, a distance of 1327.73 feet to the Southwest corner of said Section 21 also being the POINT OF BEGINNING.
