

Description

Being part of the NW1/4 of the SE1/4, part of the NE1/4 of the SW1/4 and part of the SE1/4 of the SW1/4, Section 28, Township 34 North, of Range 15 East, Town of Wabeno, Forest County, Wisconsin bounded and described as follows: Commencing at the South 1/4 corner of the said Section 28; thence N88°43'38"W along the section line 112.01 feet to the west line of the Former Chicago and Northwestern Railroad and the place of beginning; thence N88°43'38"W continuing on the same line 489.70 feet to the east line of S.T.H. "32"; thence N00°29'03"W along the said east line 462.54 feet; thence continuing along said line following the arc of a 2441.83-foot radius curve to the left a distance of 919.92 feet to a point, the chord of which bears N11°16'36"W 914.49 feet; thence N54°20'05"E 894.77 feet to the north-south 1/4 section line; thence N01°44'03"W along the said 1/4 section line 300.00 feet; thence N38°39'18"E 643.60 feet to the east-west 1/4 line; thence S89°41'33"E continuing along said 1/4 section line 590.00 feet to the west line of the Former Chicago and Northwestern Railroad; thence S35°10'10"W along the said west line 898.42 feet; thence continuing along said line following the arc of a 2914.79-foot radius curve to the left a distance of 694.05 feet to a point, the chord of which bears S28°21'32"W 692.41 feet to the one-sixteenth line; thence S89°47'46"W along the one-sixteenth line 120.05 feet to the one-sixteenth corner; thence S01°44'03"E along the north-south 1/4 section line 336.82 feet to the west line of the Former Chicago and Northwestern Railroad; thence along the said west line following the arc of a 2914.79-foot radius curve concave to the east a distance of 947.36 feet to a point, the chord of which bears S05°15'10"W 943.20 feet; thence S04°02'51"E continuing along the west line 71.35 feet to the place of beginning. Subject to that part used for town road purposes and all easements and restrictions of record. Containing 1,567,233 square feet or 35.979 acres to section line or 1,551,110 square feet or 35.609 acres to road right-of-way.
