

### CERTIFIED SURVEY PLAT FOR EVRON E. DAVISON

## DESCRIPTION OF PARCEL SURVEYED

Being a parcel of land in Government Lot 3 of section 10 and in the Northwest 1/4 of the Southwest 1/4 of section 11, Township 35 North, Range 13 East, Fourth Principal Meridian, Forest County, State of Wisconsin bounded and described as follows:

Commencing at the Meander Corner on the East shore of Lake Lucerne between sections 10 and 11 in said Township and Range; thence North 00° 13' 42" West a distance of 517.16 feet to an iron pipe which is the South Sixteenth corner between sections 10 and 11 in said Township and Range and the Point of Beginning; thence North 89° 30' 07" West a distance of 176.20 feet to an iron pipe set on the East shore of Lake Lucerne; thence North 56° 06' 41" West along the shore of Lake Lucerne a distance of 100.00 feet to an iron pipe; thence North 51° 06' 26" West along the shore of Lake Lucerne a distance of 100.00 feet to an iron pipe; thence North 4° 08' 13" East along the shore of Lake Lucerne a distance of 100.00 feet to an iron pipe; thence South 89° 30' 07" East a distance of 219.86 feet to an iron pipe set on the Westerly right of way of the town road; thence South 34° 06' 37" East along the long chord of a curve segment a distance of 121.10 feet to an iron pipe set on the Westerly right of way of said town road; thence South 42° 09' 02" East along the long chord of a curve segment a distance of 84.44 feet to an iron pipe set on the Westerly right of way of said town road; thence South 40° 58' 55" East along the long chord of a curve segment a distance of 73.37 feet to an iron pipe set on the Westerly right of way of waid town road; thence South 89° 42' 59" West a distance of 48.40 feet to the Point of Beginning.

## SURVEY NOTES

The existing town road is surfaced with black top and is within a 66 foot right of way. The road curve does not compute to a common radius so each lot was surveyed independently of a common curve. All angular measurements were measured to the nearest second of angle and all distances were measured to the nearest one-hundreth of a foot. All bearings are referenced to a solar observation.

Survey accuracy exceeds one part in three thousand error of closure.
