LEGAL DESCRIPTION

Parcel being the Southeast Quarter of the Northwest Quarter (SE 1/4 NW 1/4) of Section Twenty-seven (27), Township Thirty-six (36) North, Range Thirteen (13) East, Town of Lincoln, Forest County, Wisconsin, being more particularly described as follows:

Commencing at the South one-quarter (S 1/4) corner of said Section 27, T36N, R13E; thence N00°47'37"W along the North-South one-quarter (N-S 1/4) line, a distance of 2654.40 feet to the Center one-quarter (C 1/4) corner, point also being the POINT OF BEGINNING.

Thence N89°27'32"W along the East-West one-quarter (E-W 1/4) line, a distance of 1366.38 feet to the Center-West one-sixteenth (C-W 1/16) corner; thence N00°08'46"W along the West one-sixteenth (W 1/16) line, a distance of 1326.98 feet to the Northwest one-sixteenth (NW 1/16) corner; thence S88°58'53"E along the North one-sixteenth (N 1/16) line, a distance of 1352.20 feet to the Center-North one-sixteenth (C-N 1/16) corner; thence S00°46'17"E along the North-South one-quarter (N-S 1/4) line, a distance of 1315.96 feet to the Center one-quarter (C 1/4) corner, also being the POINT OF BEGINNING.
