
## **PLAT OF SURVEY**

## **DESCRIPTION PARCEL "A":**

A parcel of land being part of Government Lot 1 of Section 16, T.37 N., R.12 E., Town of Hiles, Forest County, Wisconsin and being more particularly described as follows:

Commencing at the Northeast corner of said Section 16, being also the Northeast corner of said Government Lot 1; thence S.89°51'37"W., along the North line of said Government 1, a distance of 377.90 feet to the Northwest corner of parcel described in Volume 275 of Records on pages 697 and 698 in the Register of Deeds Office and being the point of beginning of parcel to be described; thence S.00°08'23"E., a distance of 92.00 feet to the Southwest corner of said Volume 275, Pages 697 and 698; thence S.87°10'14"E., a distance of 125.12 feet to the Southeast corner of said Volume 275, Pages 697 and 698 and being located on the centerline of West Pine Lake Road; thence S.34°30'02"W., along said centerline, a distance of 15.63 feet; thence continuing along said centerline, S.38°25'51"W., a distance of 132.37 feet; thence N.63°28'40"W., a distance of 233.73 feet; thence N.00°08'23"W., a distance of 110.00 feet to the North line of said Government Lot 1; thence N.89°51'37"E., a distance of 175.36 feet to the point of beginning.

Said parcel contains 0.84 acres, more or less.

## **SURVEYOR NOTES:**

- 1. This survey and description is intended to be that land deeded to Duane S. Behn and Candice D. Behn as recorded in Volume 373 of Records on Pages 741-744 in the Forest County Register of Deeds Office.
- 2. In the description of Volume 373, Page 741-744 it refers to "EXCEPTING those parcels conveyed in..... Volume 84 Deeds, Page 169, ...."
- 3. I believe that reference to Volume 84, Page 169 is in error and Volume 84, page 169 no longer is an existing parcel.
- 4. Volume 84, Page 169 was a deed from Jacob Rausch and Marion Rausch to Henry and Katherine Rausch, dated September 4<sup>th</sup>, 1954.
- 5. Volume 118, Pages 540-541 is a Final Judgment in the Estate of Katherine Rausch, dated March 24, 1975 which assigned to Jacob Rausch lands that included Volume 84, page 169. Therefore this should not be an exception in the deed to Duane and Candice Behn.
