Thence, continuing along said North line, S 88°53'52" E, a Distance of 836.32' to the Northwest Corner of Lot 1 of CSM recorded as Doc. No. 199548; Thence S 00°01'37" W, along the West line of said CSM, a Distance of 356.70' to the Southwest corner of said CSM; Thence, leaving said West Line, S 88°53'54" E, along the South line of said CSM, a Distance of 330.27' to the West Right-of-Way of STH 55; Thence, leaving said South Line, and along said West Right-of-Way.
