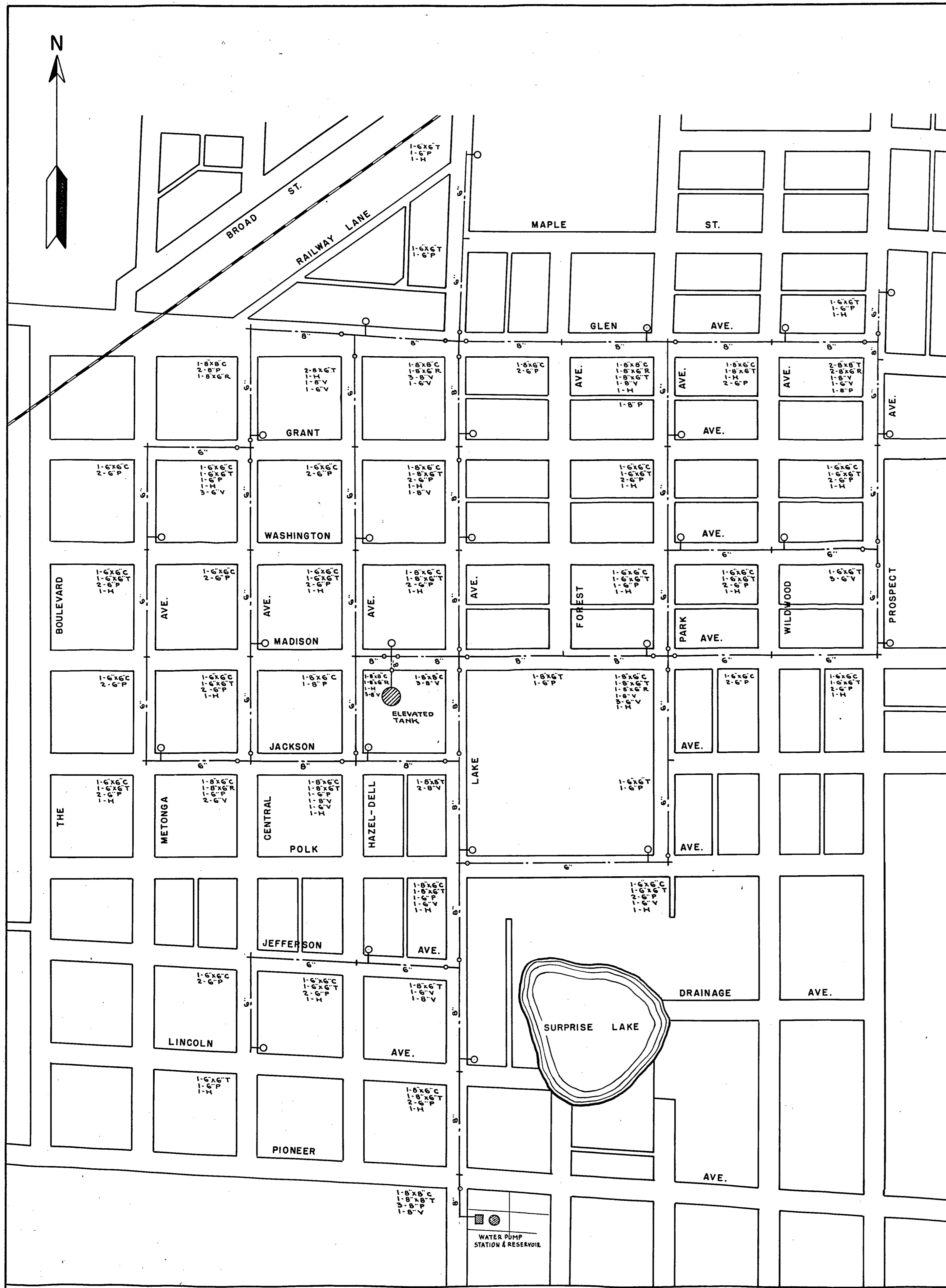

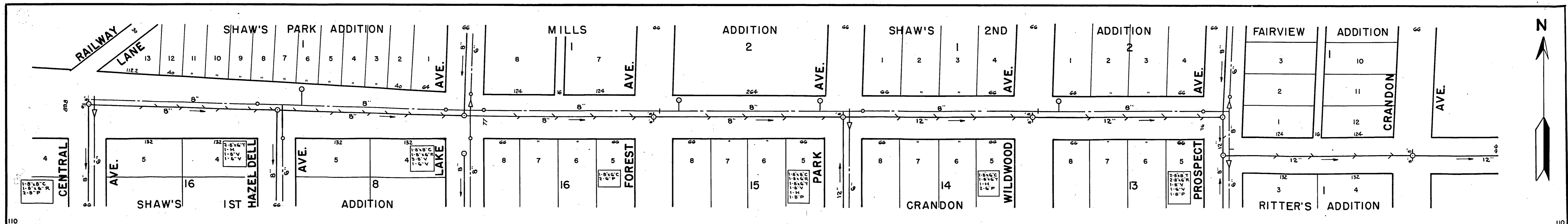


SANITARY SEWER SYSTEM
