I, J. E. Murphy, do hereby certify that I have surveyed the tract of land hereinafter described and platted the same into lots and streets under the name and title of "Moore and Hiestand's First Subdivision of Lake Hilbert" Forest County Wisconsin and I have placed iron monuments thereon at all points marked thus (iron) as thereon shown at all angles in the boundaries of said tract and that each of said iron monuments is not less than 18 inches long and not less than 2 inches in diameter and that I made the annexed map all under the order and direction of P. A. Moore and which said tract of land is that part of Lot 1 of Section 1 T. 37 N., R. 16 E. described as follows to wit:

Commencing at an iron monument in the east line of State Highway 101 184 feet northeasterly from where the south 1/2 line crosses said State Highway 101. Thence North 13° 35' East 730 feet thence South 68° East 265 feet to Lake Hilbert thence running South westerly along shore of said Lake Hilbert 690 feet to an iron monument 184 feet distant from said south 1/2 line thence west and parallel to said south 1/2 line 123 feet to place of beginning

And I do further hereby certify that the annexed map is a correct representation of all the exterior boundaries of the land surveyed and the division thereon made and that I have fully complied with the provisions of Chapter 236 of the Wisconsin Statutes for 1925 in surveying subdividing and mapping the same

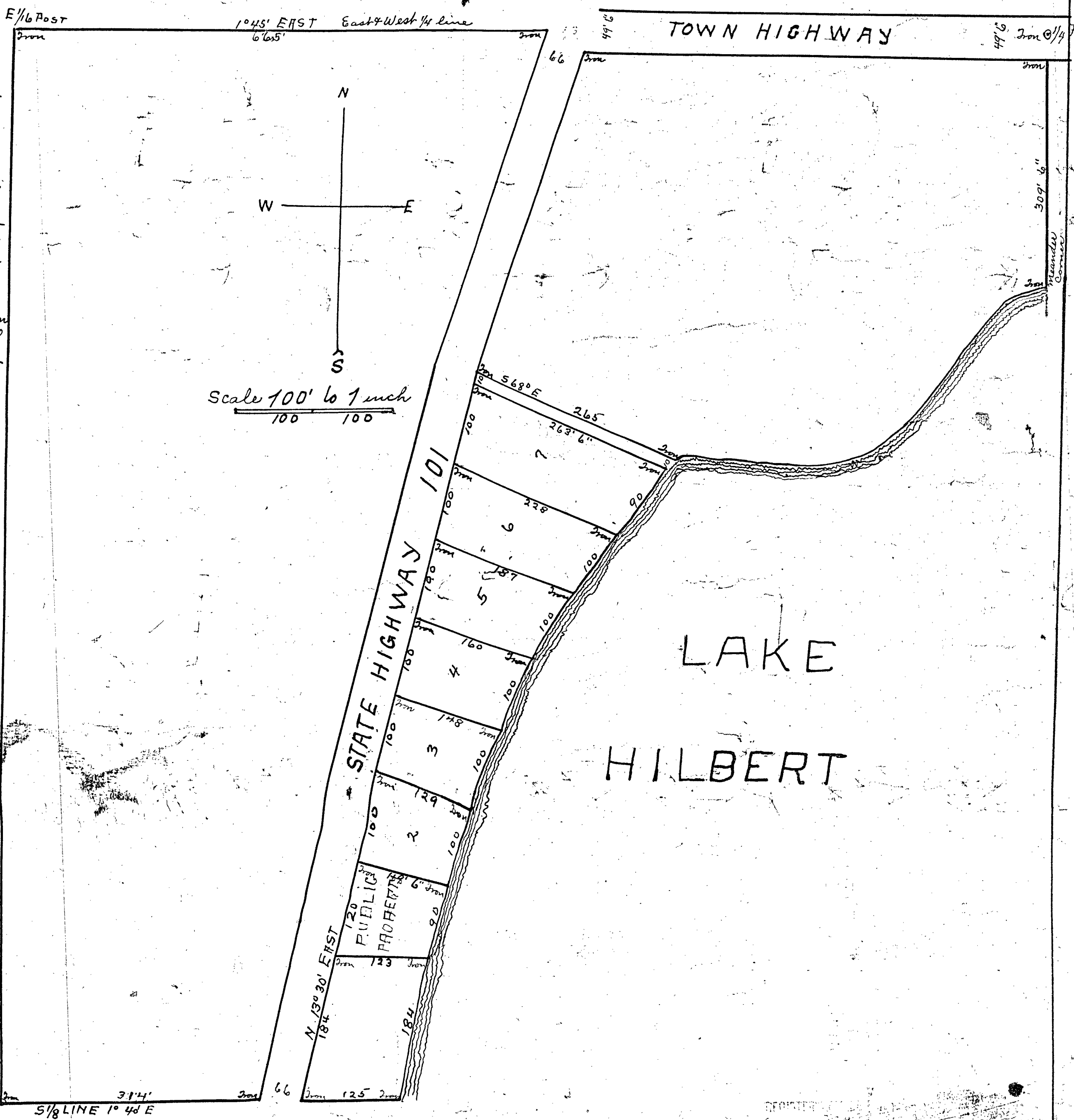
