In 1858, James McBride set a wood post with the following BTs: Hemlock, 8", N.28°W., 7 links; Hemlock, 15", S.27°E., 9 links.

In 1936, John Hammes found a Cedar stake and placed a metal location poster on the west side of the found stake.

In 1987, Alan Harrison (R.L.S.) found a 2" iron pipe in a mound of stone. Pipe is driven next to post point remains. Did not find location poster as set by Hammes. Blazed lines run east and west from pipe. Distance east to edge of swamp fits within 15 feet of original survey call. Accepted location of pipe as best corner evidence and replaced said pipe with a $2\frac{1}{2}$ " x 36" aluminum monument stamped for corner.


