
U. S. PUBLIC LAND SURVEY MONUMENT RECORD

INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through I).

(a) Identify the corner by reference to the U.S. public land survey system.
 O = Corner monument restored.

Meander Corner common to Sections 28 and 27 T37N, R12E, Forest County, Wisconsin



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

Original Government Survey in 1859 by William E. Daugherty.

In 1986, John C. Schulke, RLS, restored the corner position from the recovered original hemlock bearing tree stump. At the corner position, set a $2\frac{1}{2}$ " diameter aluminum pipe monument, 36" long, with an aluminum cap stamped as follows: T37N, R12E, MC, S27, S28, 1986, S-1665, from which the following bear:


