




 PART OF LOT 1 AND ALL OF LOT 2 OF THE PLAT OF PICKEREL POINT, LOCATED IN GOVERNMENT LOT 4 OF SECTION 30, TOWNSHIP 34 NORTH, RANGE 13 EAST, TOWN OF NASHVILLE, FOREST COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:
 COMMENCING AT THE SOUTHWEST MEANDER CORNER OF GOVERNMENT LOT 4; THENCE N 87°46'10" E ALONG THE SOUTH LINE OF GOVERNMENT LOT (4), 520.40 FEET TO THE CENTERLINE OF FLINT RIDGE LANE; THENCE N 1°43'42" W ALONG THE CENTERLINE OF FLINT RIDGE LANE, 133.88 FEET; THENCE N 25°14'34" W ALONG THE CENTERLINE OF FLINT RIDGE LANE AND TO THE POINT OF BEGINNING; THENCE S 87°59'27" E ALONG THE NORTH LINE OF SAID LOT (2), 198.81 FEET; THENCE S 70°37'38" E ALONG THE NORTH LINE OF SAID LOT (2), 100.52 FEET TO A POINT BEING 47 FEET MORE OR LESS FROM THE ORDINARY HIGH WATER MARK OF PICKEREL LAKE AND TO THE BEGINNING OF A MEANDER LINE; THENCE S 17°05'34" W ALONG THE MEANDER WATER MARK OF PICKEREL LAKE AND TO THE BEGINNING OF THE ORDINARY HIGH WATER MARK OF PICKEREL LAKE AND LINE, 162.14 FEET TO A POINT BEING 3 FEET MORE OR LESS FROM THE ORDINARY HIGH WATER MARK OF PICKEREL LAKE AND TO THE END OF THE MEANDER LINE; THENCE S 87°46'10" W 19.19 FEET; THENCE S 1°43'42" E 5.00 FEET; THENCE TO THE END OF THE MEANDER LINE; THENCE N 25°14'34" W ALONG THE EAST LINE OF FLINT RIDGE LANE, 227.85 FEET TO THE POINT OF BEGINNING, INCLUDING ALL LANDS LYING BETWEEN THE MEANDER LINE AND THE ORDINARY HIGH WATER MARK OF PICKEREL LAKE.
