

Commencing at the meander corner on the south shore of Pickerel Lake and the east line of Section 31; thence N38°12'21"W, a distance of 2148.01 feet to the southwest corner of Lot 3 of said Certified Survey Map, being a point on the east right-of-way line of South Shore Drive; Thence, N01°25'41"W, along said east right-of-way line, a distance of 60.11 feet to the south west corner of Lot 1 of said Certified Survey Map and the POINT OF BEGINNING of lands to be described;

Thence, leaving said southwest corner, N01°05'26"W, along said east right-of-way line, a distance of 155.07 feet to the southwest corner of the property described in document number 211055; Thence, leaving said right-of-way line, N73°09'41"E, along the south line of said property, a distance of 195.95 feet to a meander corner near the shore of Pickerel Lake; Thence meandering easterly and southerly along said shoreline the following courses: S53°46'52"E, a distance of 74.49 feet, and S89°21'30"E, a distance of 32.92 feet, to the northeast corner of Lot 2 of Certified Survey Map recorded as document number 120709, in volume 3 of Certified Surveys on page 73; thence leaving said meander line, S43°08'04"W, along the north line of said Lot 2, a distance of 230.77 feet; Thence, continuing along said north line, N89°31'51"W, a distance of 119.83 feet to the Point of Beginning.
