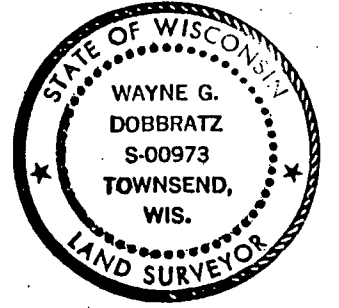


PLAT OF SURVEY

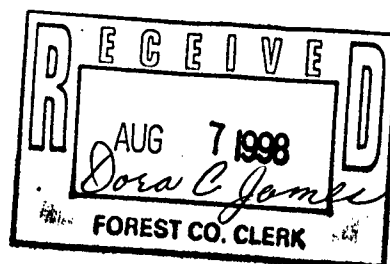
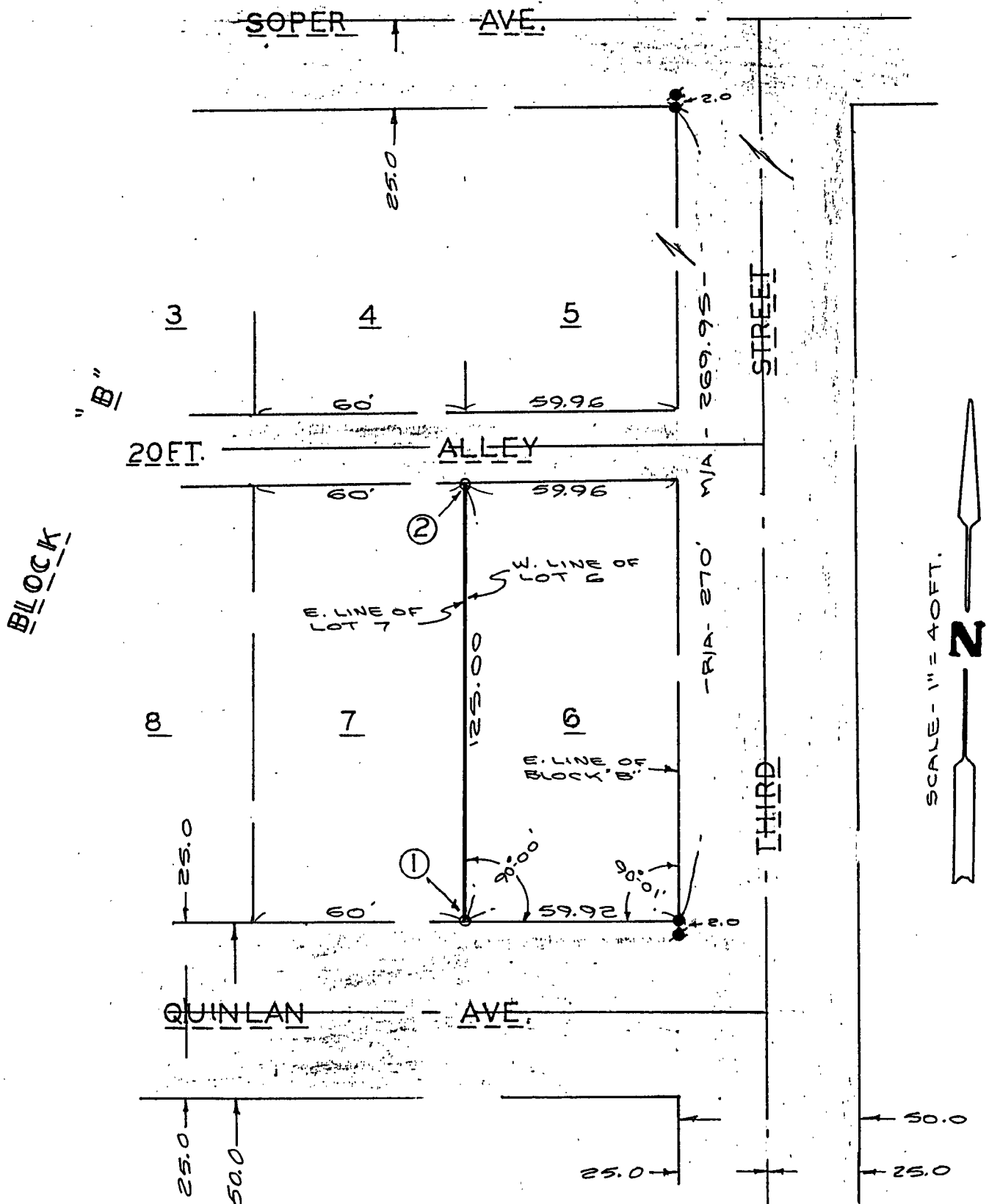
