

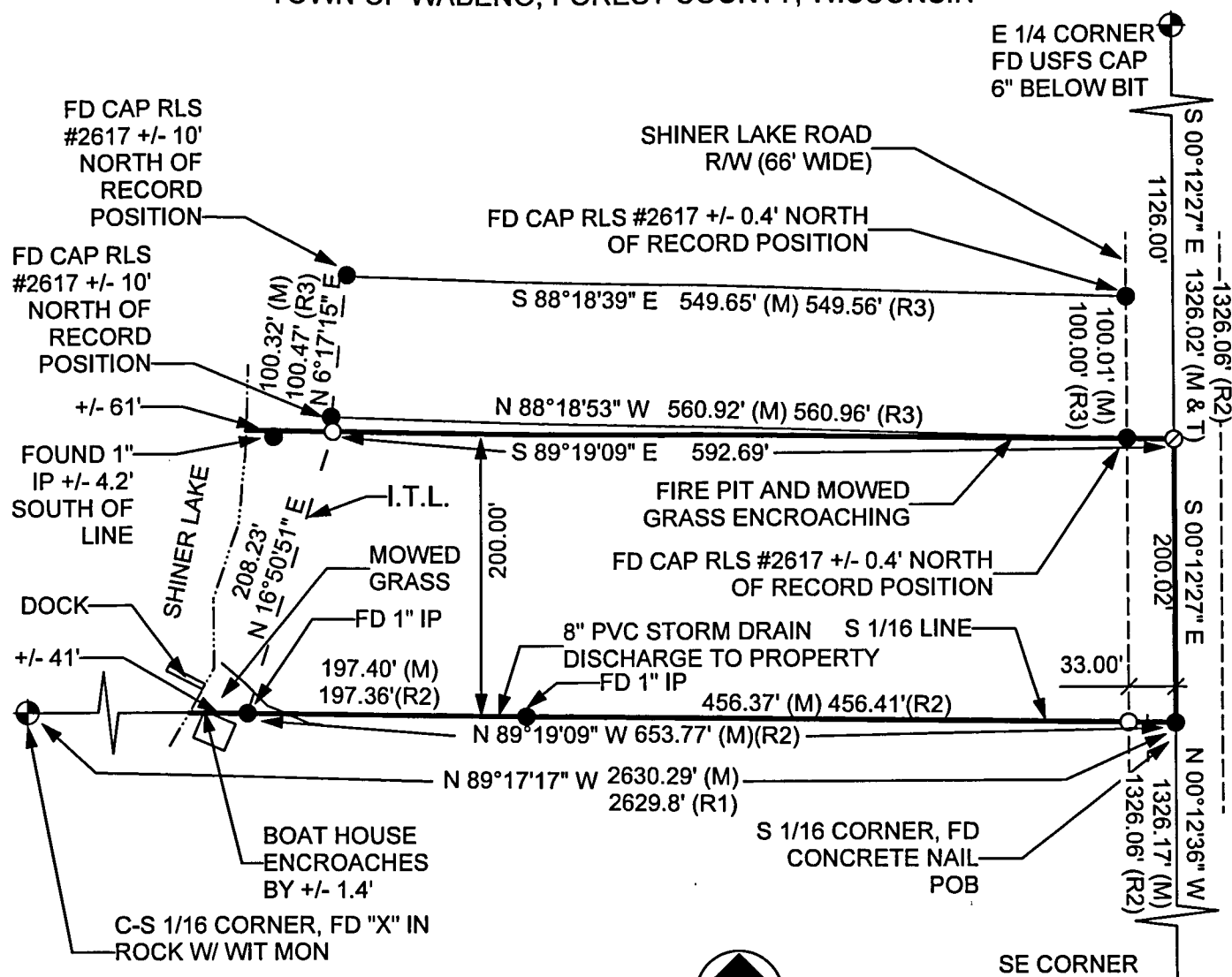

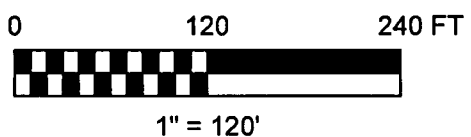

Part of the Northeast one-quarter (NE 1/4) of the Southeast one-quarter (SE 1/4), Section 29, Township 34 North, Range 15 East, Town of Wabeno, Forest County, Wisconsin, being more particularly described as follows:

Commencing at the Southeast corner of said Section 29, T34N, R15E; thence N00°12'36"W along the East line of said Section 29 a distance of 1326.17 feet to the South one-sixteenth (S 1/16) corner of said Section 29 on the East line, point also being the POINT OF BEGINNING.

Thence N89°19'09"W along the South one-sixteenth (S 1/16) line of said Section 29, a distance of 653.77 feet to the Intermediate Traverse Line of Shiner Lake; thence N16°50'51"E along the Intermediate Traverse Line of Shiner Lake, a distance of 208.23 feet; thence S89°19'09"E a distance of 592.69 feet to the East line of said Section 29; thence S00°12'27"E along the East line of said Section 29 a distance of 200.02 feet to the South one-sixteenth (S 1/16) corner of said Section 29 on the East line, point also being the POINT OF BEGINNING.
