

### SURVEY NOTES

This survey was made by Soder Surveying, pursuant to United States Department of Agriculture, Forest Service Contract #53-56A6-6-00011, True Line Survey for the purpose of marking and perpetuating the exterior and interior boundary lines of the U.S. Government land on the perimeter and within Section 34, T34N, R16E, Forest County, Wisconsin as shown on the plat herewith.

The U.S. Government lands in this section were aquired in 1934 and 1967.

The original Government subdivision survey of this township was made by James McBride in 1858. South and West lines by Artemus Curtis in 1857.

The corner positions recovered, restored, and established by this survey are marked by the monument described in the map legend.

The corner positions established were located to an accuracy of one part in 3000.

The bearings between corner positions are true bearings as determined by solar observations.

The field notes of this survey and a copy of this plat are on file in the Forest Supervisor's Office in Rhinelander, WI.
