Being more particularly described as follows:
Commencing at the Northeast corner of Section 27, Thence S00°28'00"E, along the east line of the Northeast 1/4 of said section, a distance of 1326.63 feet to North 1/16th corner of said section, being the southeast corner of Document Number 207903 and the POINT OF BEGINNING of line to be described;

Thence, leaving said east line, N85°50'51"W, along the south line of said document, a distance of 1419.83 feet to the Northeast 1/16th corner of said section, being the southwest corner of Document Number 207903 and the POINT OF TERMINATION of line description.

Said line is subject to easements, restrictions, reservations and rights-of-way of record, if any.
