

## LEGAL DESCRIPTION

Part of Certified Survey Map recorded in Volume 7, Page 49 & Part of the Northwest Quarter of the Southeast Quarter of Section 2, Township 35 North, Range 14 East, Town of Laona, Forest County, Wisconsin, more particularly described as follows:

Commencing at the South Quarter Corner of said Section 2; thence North 00 degrees 19 minutes 42 seconds East along the North-South Quarter Line of said Section 2, a distance of 1312.25 feet to the Southwest Corner of said forty; thence continue North 00 degrees 19 minutes 42 seconds East, a distance of 417.44 feet; thence North 89 degrees 42 minutes 40 seconds East, a distance of 33.00 feet to the Easterly Right-of-way line of Roberts Lake Road and the Northwest Corner of said Certified Survey Map and the POINT OF BEGINNING; thence North 00 degrees 19 minutes 42 seconds East along said right-of-way line, a distance of 66.00 feet to the Southwest Corner of Lot 1 of said Certified Survey Map; thence North 89 degrees 42 minutes 40 seconds East along the South Line of aforesaid Lot 1, a distance of 618.79 feet to the Southeast Corner of said Lot 1; thence North 00 degrees 19 minutes 08 seconds East, a distance of 169.82 feet to the Southwest Corner of Lot 1 of Certified Survey Map, Volume 6, Page 140; thence North 89 degrees 30 minutes 06 seconds East along the South Line of aforesaid Lot 1, a distance of 651.79 feet to the East Line of said forty; thence South 00 degrees 18 minutes 33 seconds West along said line, a distance of 655.64 feet to the Southeast Corner of said forty; thence South 89 degrees 42 minutes 40 seconds West along the South Line of said forty, a distance of 651.88 feet to the Southeast Corner of Lot 1 of Certified Survey Map, Volume 7, Page 44; thence North 00 degrees 19 minutes 08 seconds East along the East Line of aforesaid Lot 1, a distance of 417.44 feet to the Southeast Corner of Certified Survey Map, Volume 7, Page 49; thence South 89 degrees 42 minutes 40 seconds West along the South line of aforesaid Certified Survey Map, a distance of 618.80 feet to the POINT OF BEGINNING.
