


CERTIFIED

SURVEY NOTES

This right-of-way survey was made by the U.S. Department of Agriculture, Forest Service, across the southwest quarter of section 26, township 36 north, range 15 east, Fourth Principal Meridian, Forest County, Wisconsin.

The 66 foot wide R/W crosses the lands of Connor Forest Industries. These lands are described in Book 27 on Page 173 of Forest County deed records.

The original Government subdivision survey of this township was made in 1859. The corner positions recovered, restored, and established by this survey are marked by the monument described in the map legend.

The bearings between corner positions are true bearings as determined by references to solar observations. The closure error for the survey of the R/W perimeter was 0.01 foot.

The field survey notes and a copy of this plat of survey are on file in the Forest Supervisors office at Rhinelander, Wisconsin.

Right-of-Way Description

Fourth Principal Meridian  
 T36N, R15E, Section 26 - SW $\frac{1}{4}$

Being a right-of-way 33 feet wide on each side of centerline beginning on the section line to sections 26-35 and being S89° 29'26"E 83.3 feet from the section corner to sections 26-27-34-35 marked by a brass capped iron pipe monument stamped to identify corner position, thence along said centerline N.32°07'55"W 158.1 feet to the point of intersection with the section line to Sections 26-27 and being N.00°21'11"W 133.1 feet from the section corner to sections 26-27-34-35 all in accordance with the plat map made a part hereof and attached hereto.

Right-of-way area across SW $\frac{1}{4}$  being 0.239 acres.


