

SURVEY NOTES

This survey was made by John C. Schulke, a Registered Land Surveyor in the State of Wisconsin, for the U.S. Department of Agriculture, Forest Service. The purpose of the survey was for recovery, establishing, marking and perpetuating the corners and boundary lines of the U.S. Government Land on the perimeter and within Section 4, Township 37 North, Range 12 East, Fourth Principal Meridian, Forest County, Wisconsin.

The original Government survey of the township boundary was done by Alfred Millard, a U.S. Deputy Surveyor, in May and June of 1858. The original Government subdivision survey of this township was done by William E. Daugherty in 1859. A Dependent Resurvey on the North Township line was done by Mr. Wesson Cook and was approved by the General Land Office in 1937. The control for this North township line survey is based on the 1937 Dependent Resurvey.

The bearings between corner positions are true bearings as determined by reference to solar observations. The accuracy of this survey exceeds the State requirement for closure of 1 in 3,000. Corners recovered or established by this survey are marked as described in the map legend. Each monumented corner is referenced to blazed, scribed, painted and tagged bearing trees. Tie bearings are magnetic, and not corrected for declination.

CORNERS RECOVERED AND RESTORED

1. Section Corner Common to Sections 4, 5, 32 and 33.

Corner monument recovered in place. A square post marked with metal tags was found beside the monument. The center of Wiconsin Highway 32 is S20°W 310 feet. The highway bears N70°W. The only trees available in this area is listed below.

3. Section Corner Common to Sections 3, 4, 33 and 34.

Recovered 1937 B.L.M. concrete monument, leaning Southeasterly, reset and placed firmly as possible in the ground. Square post was laying beside the monument. Cedar tree used as a fence post corner is Southeast approximately 17.85 feet of the monument. Two track running North and South is East 40 feet of the corner.

Corner position restored by single proportionate measurement between the Northeast and the Southeast Section corners of Section 4.

5. Section Corner Common to Sections 3, 4, 9 and 10.

Recovered aluminum pipe monument in place and as described on Certified Land Corner Restoration form in the Forest County records, Document #130686, in 1986 by William Cochrane (S-1107).

6. Quarter Corner Between Sections 4 and 9.

Corner position restored as an obliterated corner at the intersection of an old boundary fence line. Monument next to a fence corner running North South and East. Old fence bears N80°W along Section line to the West.

CORNERS ESTABLISHED

1. East Sixteenth Corner Between Section 4 and 33.

Corner position is established at the midpoint and on line between the North Quarter corner and the Northeast Section corner of Section 4. The fence corner N44°E 9.6 feet which the fence line runs East and South. The monument is half way down the North side of the hill.
