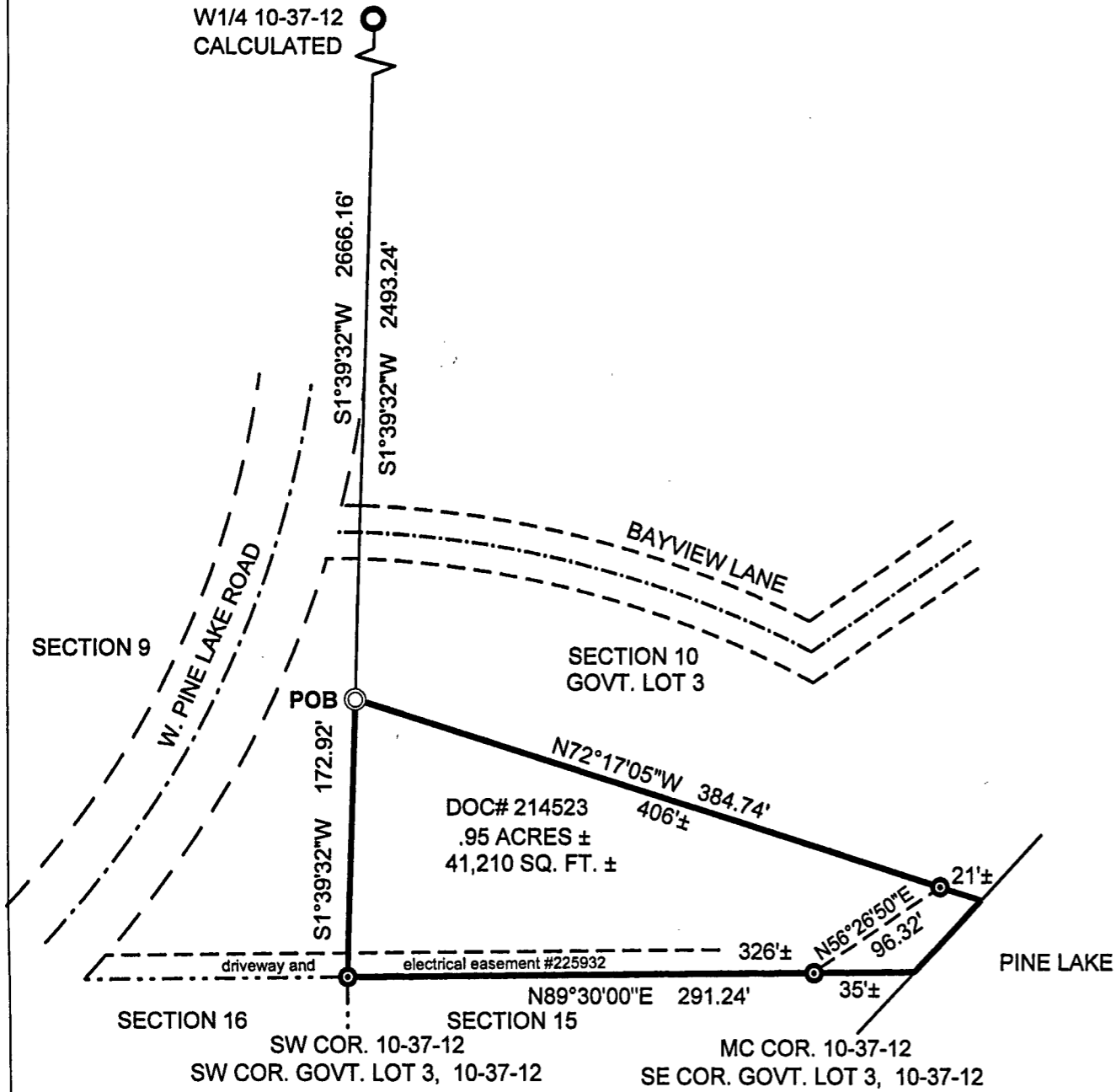


FOREST COUNTY MAP OF SURVEY

 TOWN OF HILES, FOREST COUNTY, WISCONSIN.

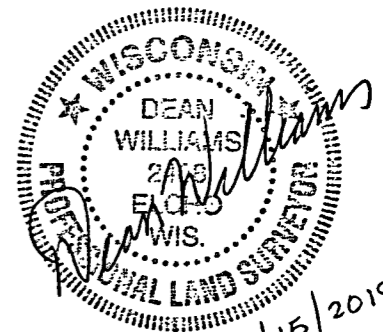

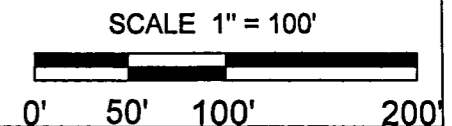

 COMMENCING AT THE W1/4 CORNER OF SAID SECTION 10; THENCE S1°39'32"W, 2493.24 FEET TO THE POINT
 OF BEGINNING; THENCE CONTINUING S1°39'32"W, 172.92 FEET TO THE SW CORNER OF GOVT. LOT 3;
 THENCE N89°30'00"E, ALONG THE SOUTH LINE OF GOVT. LOT 3, 291.24 FEET TO THE SOUTHEAST CORNER
 OF GOVT. LOT 3 OF SAID SECTION 10; THENCE N56°26'50"E, ALONG A MEANDER LINE 96.32 FEET TO A
 MEANDER CORNER; THENCE N72°17'05"W, 384.74 FEET TO THE WEST LINE OF GOVT. LOT 3; THENCE
 S1°39'32"W, 172.92 FEET TO THE POINT OF BEGINNING. THIS PARCEL INCLUDES ALL THE LAND BETWEEN
