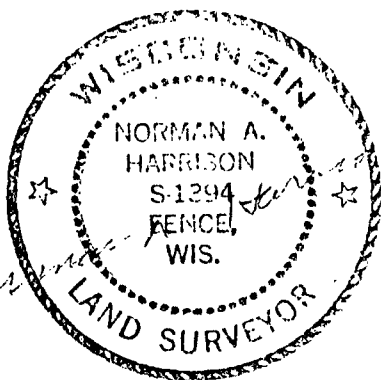

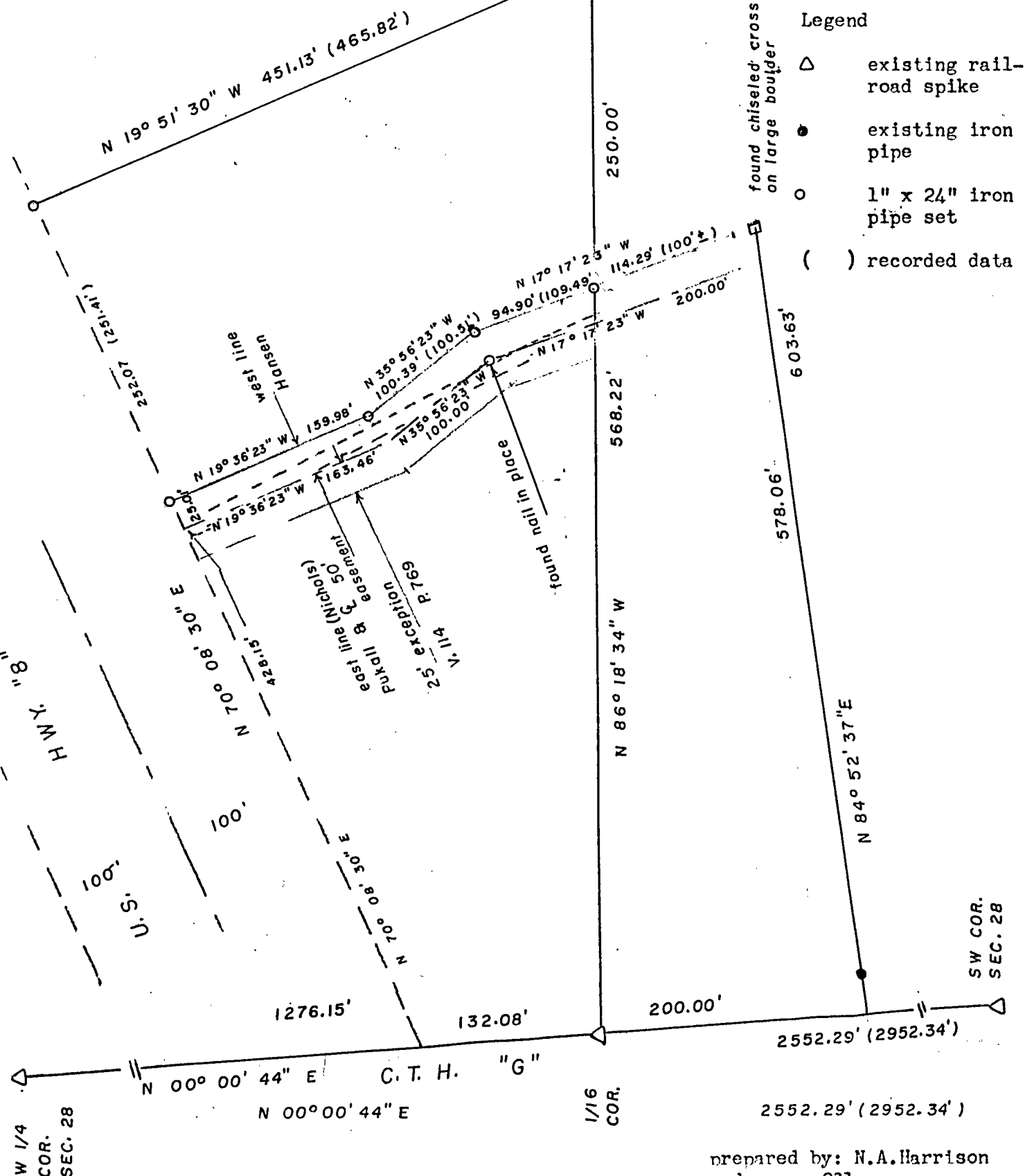

Description as furnished:

A parcel of land in the Northwest Quarter of Southwest Quarter  
(NW $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section Twenty-eight (28), Township Thirty-seven (37)  
North, Range Fifteen (15) East, described as follows:

Commencing at the southwest corner of said NW $\frac{1}{4}$  SW $\frac{1}{4}$ , thence S. 0°  
0' 44" W. a distance of 200 feet; thence N. 84° 52' 37" E. a distance  
of 603.63 feet; thence N. 17° 17' 23" W. a distance of 100 feet  
more or less to a point on the south boundary line of said NW $\frac{1}{4}$   
SW $\frac{1}{4}$  and the point of beginning; thence continuing N. 17° 17' 23"  
W. along the east line of a town road a distance of 109.49 feet;  
thence N. 35° 56' 23" W. 100.51 feet; thence N. 19° 36' 23" W.  
159.98 feet to the south line of State Trunk Highway "8"; thence  
N. 70° 08' 30" E. along the south line of State Trunk Highway "8"  
a distance of 251.41 feet; thence S. 19° 51' 30" E. 465.82 feet;  
thence N. 86° 18' 34" W. 250.00 feet to the point of beginning.
