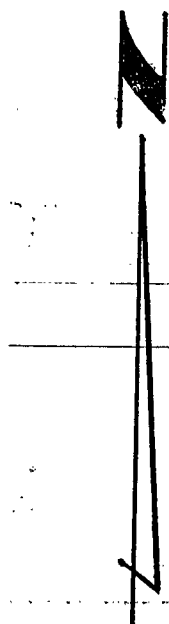


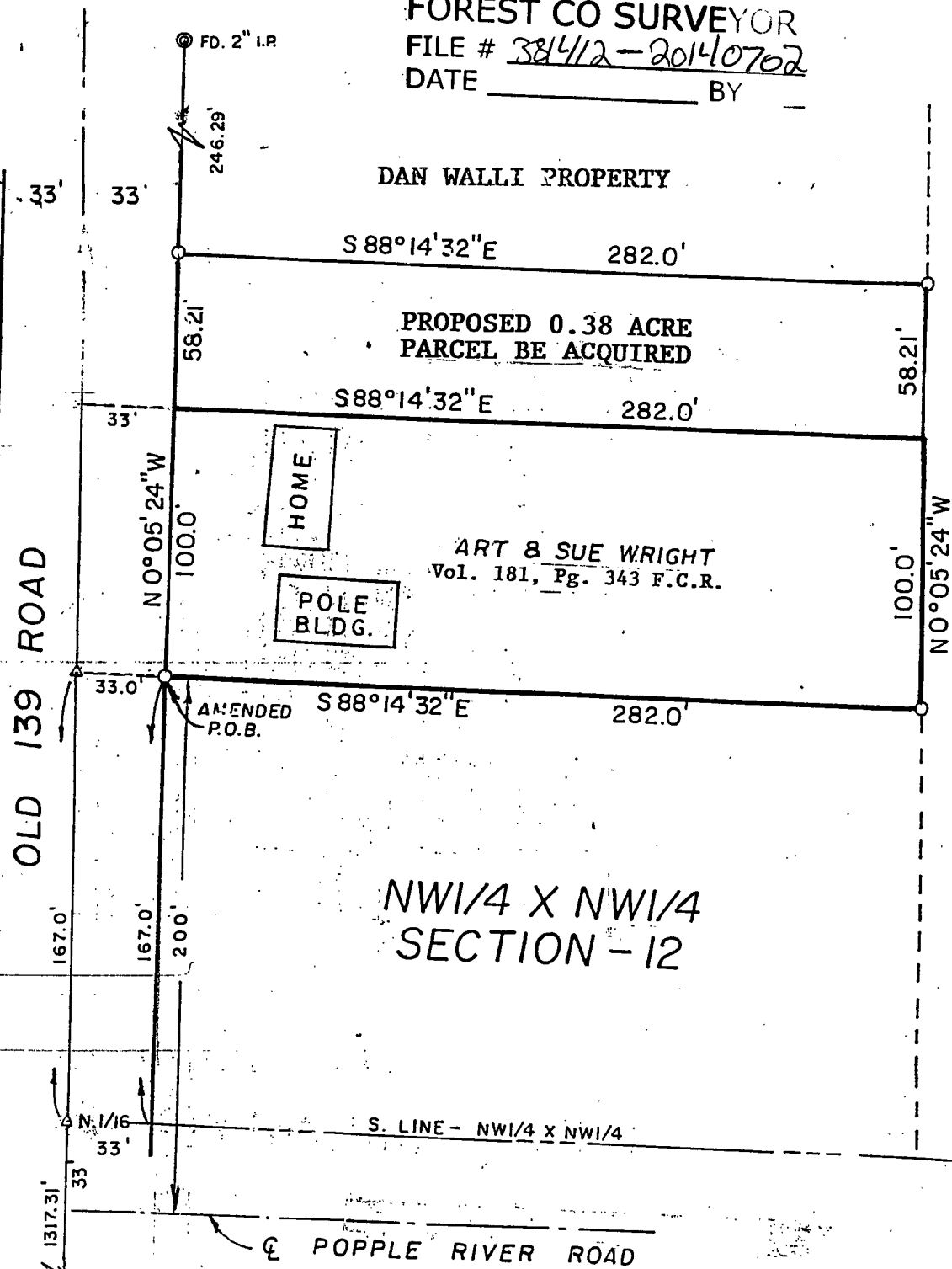

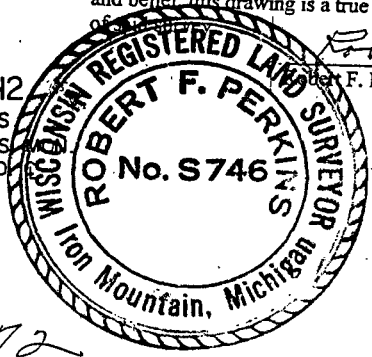

Part of the Northwest Quarter of the Northwest Quarter (NW1/4 X NW1/4) of Section Twelve (12), Township 38 North, Range 14 East, Forest County, Wisconsin more particularly described as follows;

Commencing at the West Quarter Corner of Section 12, T.38N.-R.14E.; thence running North  $0^{\circ}05'24''$  West along the West line of Section 12 for a distance of 1317.31 feet to the Southwest Corner of the NW1/4 of the NW1/4; thence continuing to run North  $0^{\circ}05'24''$  West along the West line of Section 12 for a distance of 167.0 feet (recorded as 200 feet); thence running South  $88^{\circ}14'32''$  East for a distance of 33 feet to a point on the East Line of the Town Road (Old 139 Road) and the Point of Beginning of the parcel to be described; thence running North  $0^{\circ}05'24''$  West along the East line of the Town Road for a distance of 100.0 feet; thence running South  $88^{\circ}14'32''$  East for a distance of 282.0 feet; thence running South  $0^{\circ}05'24''$  East for a distance of 100.0 feet; thence running North  $88^{\circ}14'32''$  West for a distance of 282.0 feet to the Point of Beginning.
